#### 4. Westgate Admin Report

- The projections for the upcoming year are highly promising.
- The ski trip was a success, marking the first one since 2019. It saw 95% of the usual participants, with around 12 people stayed in the lodge, which is less than the norm. The plan is to repeat this in two years, although there's a chance it might happen next year.
- The band and choir are preparing for their tour, scheduled for after the spring break. A special mention goes to Heidi Redfirm for her organizational efforts. Two-thirds of the senior students are participating.

#### 5. Review Action Items

- School Update on reaching out to Armstrong Point Per Heidi Koop: "I spoke with James about advertising our Fundraisers to the APA. He has said that in the past that has been met with mixed responses from the neighbourhood. Some have been upset. He's happy to continue to feel that out with the neighborhood, but thinks we should take it slow."
- Update on Moneris decision to be PA's new online payment platform: We were accepted by Moneris and just
  in time! There were some technical requirements, which I could not have accomplished without the help of
  my partner, Andrew Maxwell. We finished setting it all up the evening of February 16th and Stripe shut us
  down the morning of the 17th. Talk about cutting it close! Lack of sleep, stress and anxiety aside, I think this
  was a win for the PA because the online processing fees are slightly cheaper (2.85% instead of 2.9%).

- o Total Profit: \$2,336.70

#### Greenhouse Gift Cards

- We sold a total of \$7,230 (\$200 paper orders & \$7030 online orders) in Gift Cards:
  - Glenlea (15% of sales): 22 x \$25 cards = \$550
  - Lacoste (15% of sales):
    - 4 x \$20 = \$80
    - 93 x \$50 = \$4650
  - St. Mary's (20% of sales):
    - 2 x \$25 = \$50
    - 10 x \$50 = \$500
    - 14 x \$100 = \$1400
- Total online fees (between 2.9% & 2.85% because of both Stripe & Moneris): approximately \$203.87
- Total Profit: approximately \$1,117.13

### 10. Other/Call for New Business

1. As previously indicated, we were approved by Moneris. I have since learned that we had 2 different accounts with Stripe - one directly with Stripe and one with WooCommerce (website) as the middle-man between us and Stripe. I have learned that it was our account through WooCommerce that was terminated and that we still have an account with Stripe. So, it turns out that all of the stress and anxiety was essentially for nothing although on the plus side, we're paying less for online services and we have a fall-back should anything happen with Moners. That being said, both companies strictly prohibit organizations from being involved in any form of gambling such as lotteries or raffles - any decisions to participate in this sort of function should be strongly considered and NO ADVERTISING/SALES SHOULD BE ON THE WEBSITE.

- 2. PA Social Media
- While Westgate does have an Instagram account, it's not currently used for fundraising. It might be beneficial to establish an account specifically for Parent Association (PA) initiatives.
