- Lindsay in the cafeteria is providing a light lunch to the packers as they are busy and don't have much time to grab food. I think it's wraps and oat squares. As well as hot chocolate so that's fantastic!
- As far as profits go; our total profit is \$3,751. Meathurs =\$825, New Bothwell Cheese =\$674, Country Perogy =\$1498, and Pioneer Meat =\$754. Slightly down from last year but it was just the return percentages weren't as favourable as last year.

Fundscrip

- The Fundscrip Gift Card Fundraiser is over in 2 days. We are significantly behind from last year's sales but I believe that's mostly due to 1 order.
- Our sales are at \$7560.00 and profits are only \$284.65. Hopefully we get some good orders in the next couple days to make it a bit more successful.
